7. Bids shall be opened in presence of Bidders' representatives who choose to attend on 13:00 hrs on 2079/10/21 at the office of Gandaki University, Mustang chowk, Pokhara.
8. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of specified mentioned above table, which shall be valid for minimum 30 days beyond the bid validity period i.e., 120 days.
9. If the last date of submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
